Since 12th BoM, two students have successfully defended PhD thesis and seven students had their presynopsis.

Prof Banerjee indicated that <u>a clear road map should be there about the intake of students over a period so that clear growth path could be carved</u>. To this, the Chairman indicated that the idea is to have 375 M.Tech students per year and thus, the no. of students will be 750 for M.Tech and PhD will be to the tune of 200; thus making the overall strength to 1050 in all. In line with the UGC strictures, per faculty allotment of PhD students is limited, considering the teaching load, project related and institutional activities.

During the discussion, Addl FA brought out that a long term self-sustenance model for the Institute, with less dependency on Govt support should come up as these days, there is heavy scrutiny for release of grants-in-aid by FA-DS and for all grants-in-aid institutions in general, by Min of Finance, as a policy.

After a brief discussion, considering the action taken status as above, the BoM confirmed the Minutes of the 12th Meeting of BoM held on 23rd May, 2017

Item No.13.5

Agenda for discussion:

13.5.1 Foreign deputation

The Chairman indicated that the International Society for Air Breathing Engines is organizing a conference, hosted by Rolls-Royce and co-hosted by Cranfield University, from 03rd to 08th Sept, 2017 at Manchester, UK. Also, two short courses are being organized by the Cranfield University on the side lines of the conference, for the benefit of the delegates.

Since DIAT has signed an MoU with Cranfield University for promotion of Academics and for faculty / student exchange, it is proposed to depute Dr. Ajay Misra for the period from 03rd to 08th Sept, 2017, to attend the above conference, to discuss further course of academic promotion and student exchange, on the sidelines of the conference and to attend the courses. Approximate expenditure for his deputation including airfare, visa charges and per Diem allowance payable for the duration etc., will work out to around Rs. 3.5 lakhs, to be met from grant-in-aid.

Proposal:

In the absence of an explicit delegation to VC-DIAT, to depute anyone from DIAT for Conferences / Seminars etc., abroad, approval of BoM is sought for the above foreign deputation of Dr Ajay Misra.

Decision:

a. Since the date of commencement of the conference has already passed and the individual is on leave on account of personal reasons, the case need not be approved.

b. Detailed procedure to be devised as is being followed in some prominent institutions which could include, the purposes for which such cases may be allowed. The empowered committee to consider and examine the cases; selection of faculty / PhD student for such deputation with financial support; the utility / value addition of such conferences / foreign visits to the Institution / Faculty / Students and the same may be sent to the BoM members for comments. The extend of financial support to PhD students should also be examined and decided by the committee, based on Academic Excellence criterion and not as a matter of right. Proposal should be put up well in advance, for approval. The overall ceiling for financial support will be Rs.50,000/- per PhD student.

c. So far as the monetary support out of grants-in-aid is concerned, a specific amount, say, Rs.20/- lakhs per year may be earmarked and that could be got sanctioned by

DDR&D, with the Grants-in-aid.

d. With the recommendations of the empowered committee, the BoM may consider approval for such foreign visits with Institute support.

Action: DIAT

13.5.2 Composite payment equivalent to ONE increment to contract faculty on extension / reappointment

As per para 7.1 of the Rules and Regulations Governing Service Conditions of DIAT 2009, the institute is authorized to "appoint employees on contract, against sanctioned vacant posts, pending finalization of the process of recruitment on regular basis, in terms of recruitment rules".

Though, the institute is regularly advertising for the faculty positions (mostly reserved vacancies for SC/ST/OBC), suitably qualified candidates are not found (as per the applications received / interviews held).

As such, positions are filled by appointing contract faculty for a year or less initially. Many a time, the institute has been constrained to re-appoint them for another term or so, due to continued non-availability of candidates against regular vacancies.

As per para 7.3 of the regulations (ibid),"such contract appointees shall be paid consolidated lamp sum monthly remuneration which shall not exceed the quantum of emoluments at the minimum of the basic pay of the post plus applicable dearness allowance".

<u>Proposal:</u> To extend a nominal amount as increment, (say, ~Rs. 1000/-) for the contract faculty continued / term extended / re-appointed.

Decision:

a. Such extension of increments may create legal issues.

b. Regular advertisements for contractual positions (against vacant positions) may be released well in advance against which, the existing contract faculty may also apply. Selection to be made by a designated committee, based on merit.

c. No increment to be extended even if selected for another term. But, on account of DA etc., if the minimum pay goes up, that may be extended uniformly, to all such

contract faculty.

Action: DIAT

13.5.3 Creation of the post of Pro-Vice Chancellor at DIAT

Para 6.5 of the UGC deemed to be University Regulations 2016 provides for a position for Pro-Vice Chancellor for Deemed to be Universities.

The position of Pro-Vice Chancellor may be created with the approval of BoM and Central Government as per provision (i) of para 6.5 and to be appointed by BoM on the recommendations of the Vice Chancellor

His term shall co-terminus with the office of Vice Chancellor and the pleasure of Vice Chancellor and shall be delegated powers and duties as prescribed by Rules of the institution deemed to be university.

Pro Vice Chancellor shall be a member of Board of Management, Academic Council, Finance Committee and as an officer of the deemed to be university, as per UGC DU Regulations.

The DIAT Statues 2009 approved by the Hon'ble RM does not provide for the position and such, the position is not in operation at present.

DRDO vide its letter dtd 22th Aug, 2017 communicated that "DRDO would like to consider creation of Pro Vice Chancellor post at DIAT as per UGC norms" and that "the BoM may deliberate the terms of appointment, salary, rules and responsibilities related aspects in the forthcoming meeting"

Proposal: BoM is requested to approve creation of the position of Pro-Vice Chancellor

Decision:

- a. BoM approved creation of the position of Pro VC.
- b. Detailed modus operandi to be devised in line with the practices in prominent universities.
- c. Detailed role of the Pro Vice Chancellor to be drawn out, in view of the UGC Rules and the practices being followed by prominent universities into account.
- d. DIAT to take up the matter with the Govt / Dept about the requirement and to sanction the position, indicating the financial commitments on pay and allowances, after due deliberations in the next BOM.

Action: DIAT

13.5.4 Engagement of Dr S B Singh, M.Tech (Metallurgical Engg) and PhD (Metallurgical Engg), as Visiting Professor

Proposal was moved to engage Dr S B Singh, B.Tech (Industrial Engg); M.Tech(Metallurgical Engg) and PhD (Metallurgical Engg) and former Director, NMRL/DRDO as a Visiting Professor, on a consolidated honorarium of Rs 60,000/- per month and other DIAT terms and conditions of engagement of Visiting Professor, for the Dept of Materials Engg. Detailed Bio-data was presented.

As per para 4.4(v), powers of the Board of Management of the UGC (Institutions Deemed to be Universities) Regulations, 2016, BoM has to "provide for appointment of Visiting Fellows and Visiting Professors".

<u>Proposal:</u> Approval of the BoM was sought for the appointment of Dr S B Singh, for a period of 1 year initially.

Decision:

- a. The instant case approved.
- b. Such engagements may be for a maximum period of 2 years;

Action: DIAT

13.5.5 Rustication / Expulsion Rules

As of now, DIAT has no provision to rusticate/ expel a student involved in activities unbecoming of a student/ for academic non-performance. The set of rules devised for consideration by BoM for approval is as under:

Rustication and Expulsion Rules .

- 1. The following shall constitute indiscipline, liable for rustication:
 - · Failure to pay college or hostel fee in time.
 - Failure to come up to the prescribed standards in performance.
 - Improper conduct or behaviour.
 - Involvement in sexual harassment cases
 - Participation in any political / unsocial / unlawful demonstration.
 - Being involved or having been involved in the past in a criminal case or moral turpitude.
 - Indulging in any activity derogatory to the institute.
 - Consuming or found in passion of narcotic / drug or liquor.
 - · Indulging in ragging case.
 - Approaching higher authorities / law enforcing authorities directly, without exhausting all prescribed grievance redressal mechanisms of the institute.
- 2. Before rusticating or expelling a student, an enquiry shall be held by the duly appointed committee and adequate and reasonable opportunity shall be given to the student concerned to explain his/ her position and a complete record of the case shall be maintained.

Proposal: To approve the rustication / expulsion rules for DIAT:

Decision:

- a. Proposal approved in principle;
- Detailed guidelines and procedure for grievance settlement to be circulated to the students through appropriate media;
- c. Dos and Don'ts to be clearly intimated to students;
- d. Detailed rules for rustication / expulsion to be devised and discussed internally, with student representatives; the same to be got vetted by a lawyer to ensure lawfulness.
- e. An undertaking to be obtained from students on the dos and don'ts and rules as "read and understood" during the admission stage itself for new entrants and for others, while implementing the same.

Action: DIAT

13.5.6 Ad-hoc arrangements for Selections and promotions in the absence of Chancellor's nominee:

Dr. Raghunath Shevgaonkar's term as Chancellor's nominee ended on 7th June, 2017. Though, a proposal was sent for Chancellor's approval for nomination, approval is still awaited. Interviews for faculty positions are lined up but due to the absence of a Chancellor's nominee the same could not be held.

Proposal: To continue with Prof. Raghunath Shegaonkar as Chancellor's nominee till a fresh nomination is received or go ahead with selections / promotions without Chancellor's nominee.

<u>Decision:</u> DIAT may continue with Prof. Raghunath Shevgaonkar as Chancellor's nominee till a fresh nomination is received.

Action: DIAT

As per the letter of appointment extended to the selected faculty during 2010/2011 viz., Mr M T Abhilash, Mr Sunil Nimje, Ms Sunita Dhawale, Ms. Upasna Singh, Ms Deepti Vidhyarthi and Mr Kailas Sawant, [who joined DIAT with M.Tech qualification and without PhD], there was a stricture that they have to complete PhD within 5 years of their joining, failing which, the subsequent annual increments will not be drawn. Of these faculty members, Mr Sunil Nimje, Ms Upasana Singh and Ms Sunita Dhawale acquired PhD Degree within 5 years of joining DIAT whereas others are yet to complete the PhD degree. However, the offer of appointment to Mr Vinay A Yadav, who was also appointed during 2011 without PhD, did not have this clause. The annual increment of those who did not complete PhD within the prescribed 5 years were not drawn during July 2017.

Proposal:

Since there is contradiction in the above cases and since stoppage of increment is considered a punishment, BoM is requested that their increments may be restored; however, promotions under CAS will be subject to their completing PhD and will be governed by the relevant DIAT Rules 2016, as approved by BoM and Governing Council.

Decision:

Proposal approved.

Action: DIAT

13.5.9 Contingency grant for M. Tech. Scholarship students

As per clause 7.2 of 'Rules and Regulations of the Post Graduate Programmes 2016', M Tech scholarship students would be entitled for contingency grant (presently Rs. 5000/-each year) in accordance with the decisions of the Institute.

Proposal:

M Tech Scholarship students may be permitted to utilize contingency grant (limited) towards TA/ Registration fee for attending seminars/symposia/ conferences within the country, visit to DRDO/ other labs/industrial visit and any other visit specifically authorized by the institute only and not for any other purpose. The upper ceiling will be R.5000/per annum.

Decision:

Proposal approved. However, if AICTE extends contingency fund, the utilization shall be for purposes stipulated by AICTE.

Action: DIAT

As per directions laid down under Rule 212 (3) (iv) of GFR 2005, the 'Annual Reports and Audited Statement of Accounts' of DIAT are to be Tabled in Lok Sabha and Rajya Sabha in the winter session of Parliament after authentication by Hon'ble Raksha Mantri.

13.6.1 Considering Retired Scientists of DRDO against positions of Faculty on deputation, if regular Scientists are not deputed:

DIAT has 20 faculty positions, to be filled up by DRDO scientists on deputation terms. Of these, only 3 positions are filled up by DRDO Scientists and rest are vacant. DRDO has allowed DIAT to fill 6 out of the 20 positions, by faculty on contract, which are yet to be filled.

Proposal: To fill up the vacuum, against the large scale requirement of faculty to

teach 27 specialisations, it is proposed to consider retired DRDO Scientists.

. . Ocientist

Decision:

a. All efforts to be taken to get DRDO scientists on deputation.

- b. In case of non-availability of serving DRDO Scientists due to other commitments / indispensability by the Dept., retired DRDO personnel [Scientist F Equivalent or above] may be considered for recruitment for a maximum term of 3 years or till the incumbent turns 65, whichever is earlier.
- c. Advertisement specifying the qualifications; areas of expertise and experience requirements will also be published *in DRONA*, inviting applications from interested candidates.
- d. Due recruitment process as in the case of regular faculty to be followed. The incumbents may be paid salary as applicable to Professors, limited to the maximum of the OS scale, less the pensionary benefits.
- e. Serving DRDO Scientists only will be eligible for the 30% Training Allowance.
