27.5.5 Review and updation of DIAT Statutes and Rules and Regulations Governing Service Conditions, 2009

The Rules and Regulations Governing Service Conditions, 2009 of DIAT Statutes has not updated since 2009.

Sonstation

It is proposed to revise / update the Rules and Regulations Governing Service Conditions, 2009 by incorporating Govt of India orders [DOPT/UGC/MHRD/MoF etc.] issued from time to time.

Discussion:

Dy Registrar (Admn) briefed that the DIAT Statute was last revised in 2018 by incorporating amendment issued till 2016 and the Rules and Regulations Governing Service Conditions, 2009. Thereafter, the 7th CPC had been implemented at DIAT. Based on UGC has also issued pay scales for teaching faculty. The existing information in the Rules and Regulations Governing Service Conditions, 2009 are as per the 6th which required complete revision according to the latest orders of the Govt of India. Therefore, a proposal is put to constitute a Committee which can go through the revisions thoroughly and submit its report within six months as the minimum six months time is required to revise and incorporate all the provisions.

27.6.1 Overview on the NEP 2020 and implement the relevant provisions at DIAT.

Prof. Sangeeta Kale, Chairperson, the Committee of NEP 2020 made a presentation on the NEP 2020. Prof. Kale informed that a Committee had been constituted by the Vice Chancellor for adoption of NEP 2020 in the area of higher education. The presentation made by Prof. Kale is enclosed as **Annexure-27.6.1.**

Prof. Kale informed that the NEP document were also discussed in PGC and DRC in detailed and the recommendations made by these Committees were also included in the policy docs like economic indecency, entrepreneurship, start-up acceleration, categorization of the university, faculty development, increasing the student ratio by 2024, induction of online courses & commencement of open-distance course etc.

Prof. Kale also informed that the M.Tech prog would be a multidisciplinary in nature students can change their subject according to their choices.

- 1.3 Students from the academia are selected based on qualifying GATE/ SET/ NET/ CSIR scores and clearing the written test and interview conducted by DIAT(DU). At present it is limited to 20 candidates / Academic Year across all the departments.
- 2. At present, there are 52 permanent faculty members in DIAT, and the breakup for which is given below:-

i. Professors	- 10
ii. Associate Professors	- 10
iii. Asst. Professors	- 32

3. As per the UGC norms, each of the category of the faculty members given above are eligible to research scholars for Ph. D. Programs as per the details given below:

i. Professors	- 8
ii. Associate Professors	- 6
iii. Asst. Professors	- 4

- 4. The faculty in DIAT are at a disadvantageous position on this account. Though there are a lot of demands for admission to Ph. D. in various discipline and departments, DIAT restricts the admission of research scholars up to 20 this academic year for reasons mentioned above.
- 5. It is indeed worth mentioning that most Ph.D. scholars, upon award of the degree, go abroad for their post-doctoral programs in reputed universities or join IITs and such good institutes in India. This brings out the inescapable necessity to generate financial resources to enable taking more number of research scholars in DIAT with sufficient funding.

Decision:

It has been decided that before finalizing the proposal for increase of PhD students strength from 20 to 52 is to be taken up with DRDO HQ for funding.
