This has reference to your application I.D. No. 5946-02/09/2021 seeking accreditation by National Board of Accreditation to PG Engineering programs applied by Defence Institute of Advanced Technology, Girinagar, Pune, Maharashtra – 411025.

2. An Expert Team conducted onsite evaluation of the programs from 26th to 28th August, 2022. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Defence Institute of Advanced Technology, Girinagar, Pune, Maharashtra – 411025 as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.

9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
